TGC's Stretch and Flex Plan Designed to Prevent Injuries by Mike Haller

Employees at The Gallegos Corporation perform physical activities while at work whether they are in an office or on a project site, so the importance of stretching is a key element in helping to prevent work-related injuries.

The US Bureau of Labor Statistics recently reported that strains and sprains are the leading injury in the workplace and account for more than 43 percent of the total nonfatal occupational injuries in the private industry.

At TGC, the safety and well-being of our workforce is our number one priority. Our company has an outstanding safety record and believes that all accidents are preventable.

The Stretch and Flex Program was developed to help reduce the risk and severity of back and musculoskeletal disorder (MSD) type injuries that are prevalent on the job. There are 14 easy stretching exercises that take about 5 to 10 minutes that help target a variety of muscles used in a wide-range of physical activities.

Typically, employees perform these exercises in a group prior to starting their work activities for the day. Performing the Stretch and Flex Program as a group helps create a team atmosphere and helps to build employee moral. Each employee is also encouraged to warm up after each break and lunch period.

Daily stretching can create positive benefits. The most important benefit of the Stretch and Flex Program is that stretching increases an employee's health benefits not just at work but also in their activities outside of work.

Several faces from The Gallegos Corporation along with their family members participated in the 5K—

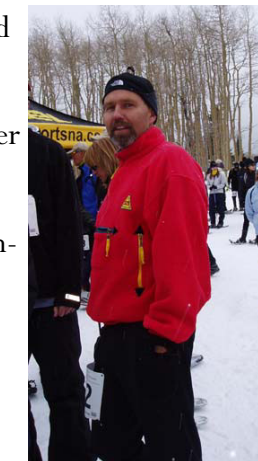

Answers to Your PTO Questions

Our new PTO policy went into effect on April 1, 2006.

Human Resources has received several questions since then on how the new policy works. Here is the most frequently asked question.

How did you figure out how much PTO time I have as of April 1, 2006?

First we looked to see how much vacation you had available under the old policy as of April 1, 2006 and we put that amount into your PTO "bucket". Then we looked at how many months it had been from your last anniversary date to April 1, 2006 to see how much vacation you had earned since that last anniversary date. Then we put that amount into your PTO bucket. Then we looked to see if you had sick time available and if you did we put into your PTO bucket the 12 hours we all earned between January 1, 2006 and April 1, 2006—unless you took sick time during that time. Those who have sick time will accrue the remaining 4.5 days over the year as part of their PTO. That is how we figured out what would start in your PTO bucket.

If you want to know your exact amount give HR a call and we will be glad to tell you. You should start seeing the amount of PTO time you have accrued on your paystub within the next few months.

New Projects, New Offices

In 1970 The Gallegos Corporation was formed. In just over a decade, it became the masonry contractor of choice in the Vail Valley—and in the newly developing Beaver Creek. Soon thereafter the company expanded into other trades (stucco, plaster, marble, granite, art rock) keeping its moniker synonymous with distinguished craftsmanship and enforcing a top-notch work ethic from its crews.

Soon enough, the company's reputation spread and its services were in demand not only across Colorado but across the greater Western United States. The Vail Masonry crew was routinely heading to the Aspen area to work on big, custom homes, sometimes driving over early on Monday morning, having a few guys share a room and spending the week working in Aspen's distinctive market.

"It was a crazy time," says Jake Jacobson, Division 20 president, who worked on many of the jobs in Aspen in the early and mid 80s. "Some of the large projects that drew us to the Roaring Fork Valley were Starwood and Red Mountain."

A few years after the masonry crews began working in Aspen the Stucco/Plaster guys followed suit. In 1988 the plaster and stucco crews were driving back and forth daily to work beside their masonry division coworkers.

"Aspen was a growing market," says Gary Woodworth, Division 31 & 40 president. "The Aspen area architects had a think outside the box approach. The homeowners wanted quality work and understood The Gallegos Corporation could deliver it."

It was the early 90s when the Marble/Granite division started working in the Aspen area doing slab work in the same homes. "Competition has increased over the years," says Gary. "But there is still growth." And although Aspen city planners hope to try to establish tougher building guidelines over the years, TGC still finds there are many large, unique projects in the area. And similar to Eagle County, work is creeping down valley on Highway 82.

The company's expansion has been more than just westward. In 1999, The Gallegos Corporation looked to the east and founded the only divisions that are not based in a resort community: Denver's Masonry and Plaster/Stucco. For the most part, these two divisions' focus is not on building 2nd and 3rd homes for vacation purposes, but building primary residences. From the masonry aspect the architecture in the Denver metro area is also more formal, with the primary building material being limestone and mostly dimensional patterns with a lot of cut stone detailing.

Denver Masonry's first large projects were the Grace, Myklak, and Shanahan Residences, the Bennett Horse barn and Star Ranch. "Some memorable projects have been the Bartlet Residence, a super custom home, built on a cliff above Castle Pines International Golf Course. Another project was Castle Hawk, with its 18th century Tuscan style stone work and reclaimed antique fire place surrounds that were removed from a castle in France, shipped to the US and reconstructed on site with no plans or drawings," says Mike Morrissey, Division 22 president.

Other inspiring projects include the Miller Residence, a 25,000 sf custom home in Colorado Springs, the Marsico Residence in Cherry Hills Park and the Sie Residence in Buehl Mason with its 100-foot long Feng Shui water falls.

"The custom residential market seems to be staying steady and as our client base has increased we have seen steady growth," Mike says.

The Denver Plaster division started with its new projects prior to the Masonry division, but really started gaining projects in earnest around 1998 or 1999 too, says Gary Woodworth, Division 32 president. It was around this time that the division was being built into what it is today—a division with a large volume of work and a mix of residential and commercial projects.

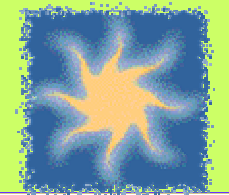
"Our first large job was a private residence in Cherry Hills," Gary says. "It had a lot of ornamental plaster, simulated limestone plaster, and colored veneer plaster."

However, as with many of our markets, it's challenging to continue to find those distinctive projects that sets The Gallegos Corporation from its competitors. "We've experienced good growth, tremendous growth over the last three years," Gary says. "Currently the mix is more commercial but there are also some residential projects."

One of the more recent divisional launches has been in Telluride, where Jamie Woodworth and his crew set up shop, and currently Dan Patton still goes after some of the more impressive projects.

The projects are primarily Plaster/Stucco but Masonry and Marble/Granite has found some work there as well. One of the first projects was a 50,000 square foot house in Ridgway. "We used that project to launch into Telluride," Gary says. "It was the first job of significance and we used that to establish a base of operations and started to bid work in Telluride."

While not one of the largest markets for Gallegos, there are spectacular high-end projects in the works. "A lot of architects went from Aspen to Telluride, where the projects are similar to Aspen but with more creative freedom: they are really unique," Gary says.
